

# Tanger changed to student program center

New student housing recommendations for the Plymouth Canton Community Schools were approved by the district Board of Education last week.

The recommendations — part of a package of changes for the 1988-89 school year — are based on a review of current student housing patterns, planned community development, a

projection of future needs and discussion among members of the student housing steering committee, said Michael Homes, assistant superintendent of instruction.

"We've only begun to solve the housing problems in the district," said board member E.J. McClendon. "There are problems still out there and still coming up."

The big change for 1988 is the

conversion of Tanger Elementary School to a center for a variety of student programs (including Special Education) and staff development.

The major changes for 1988-89 include:

- Assignment of all ninth grade students in the Lowell attendance area to the Centennial Educational Park (CEP).

- Assignment of elementary students

in the current Tanger School attendance area, exclusive of Special Education students, to the Farrand Elementary School.

- Temporary conversion of Tanger School to alternative use for designated student programs and services (IPSEP, PLUS, Head Start) and continuation as a center for staff development.

- Complete the phase-in of all

### Journeys from Vietnam to Canton

# Refugee finds peace in P-C

"Have you ever been on the ocean? I'll tell you, all it is, is the sky, water and you."

So says Minh Quach, a Vietnamese refugee who left his native country at the age of 10 along with thousands of other Vietnamese "boat people."

Quach tells his story while seated comfortably in the Salem High School library. A 17-year-old senior, he very much looks the part of a contented teenager. He smiles softly during the conversation and stumbles occasionally on a word. Otherwise, he seems to have mastered the English language in the short time that he's been here.

"Thinking back, it was all sort of an adventure game," laughs Quach. "It's really difficult to describe, I'm not sure that I can."

Quach played out his real-life "adventure game" in postwar Vietnam, a tough place to live if you weren't willing to embrace the communist lifestyle.

Two unsuccessful escape attempts, which included his father, uncle and little brother (now a student at West Middle School), were made before the Quaches finally were able to emigrate legally.

The first attempt failed and resulted in the six-month imprisonment of Minh and his brother, and a year-long sentence for his father and uncle. Quach was imprisoned at an age when most of his American counterparts were playing little league and watching cartoons.

"Our jail was an old, abandoned temple and we were only allowed 10 minutes a day to go outside for air. Hundreds of people shared one porcelain pot for a toilet," recalls Quach. "We all changed and we lost weight, but we learned something. I will always remember that place."

Eventually, the communist government abandoned its hope of "re-educating" those who were unwilling to "learn" and decided to let

those who wanted to, go.

Freedom, though, came at a price. To leave, one had to relinquish his/her land and pay the government a large sum of money, a sum large enough to leave many Vietnamese penniless, recalls Quach.

The Quaches, though, saw no alternative and jumped at this chance.

Together with his four family members and five other extended family members, Quach gladly boarded an overcrowded boat and headed off into the unknown.

The ragged fleet drifted for a long time, rarely sighting land.

"I remember that when we would sight land, everyone would jump up

and cheer, we really had no idea of where we would land," says Quach. "When we got to Malaysia, their navy would not let us land. They came out and towed us into international waters and pointed us to Indonesia."

While barren refugee camps in the Indonesian mountains hardly seem comfortable, they were relatively easy compared to the life on the overcrowded, leaky boats.

"We lived in a camp called Ku Ku (Quach is uncertain of the spelling) which was a small island with no electricity and little clean water — when I study biology, it brings it all back," laughs Quach. "It was very poor there. We sold all of our remaining belongings for food and to convert it into money to buy supplies."

The Quaches remained at Ku Ku while their paper work was processed. They lived on canned foods donated from nations around the world. Quach remembers that "even canned sardines were delicious when you didn't have food, I ate sardines all day."

In the second camp, the refugees lived in barracks.

"We had electricity at Galang and light from street lamps," says Quach. "The Peace Corps set up pipes to bring in water — you were very happy to see

Organizers of the Country Fest, the Canton Chamber of Commerce, the township's Community and Economic Development department, the Canton library and the Canton Beautification

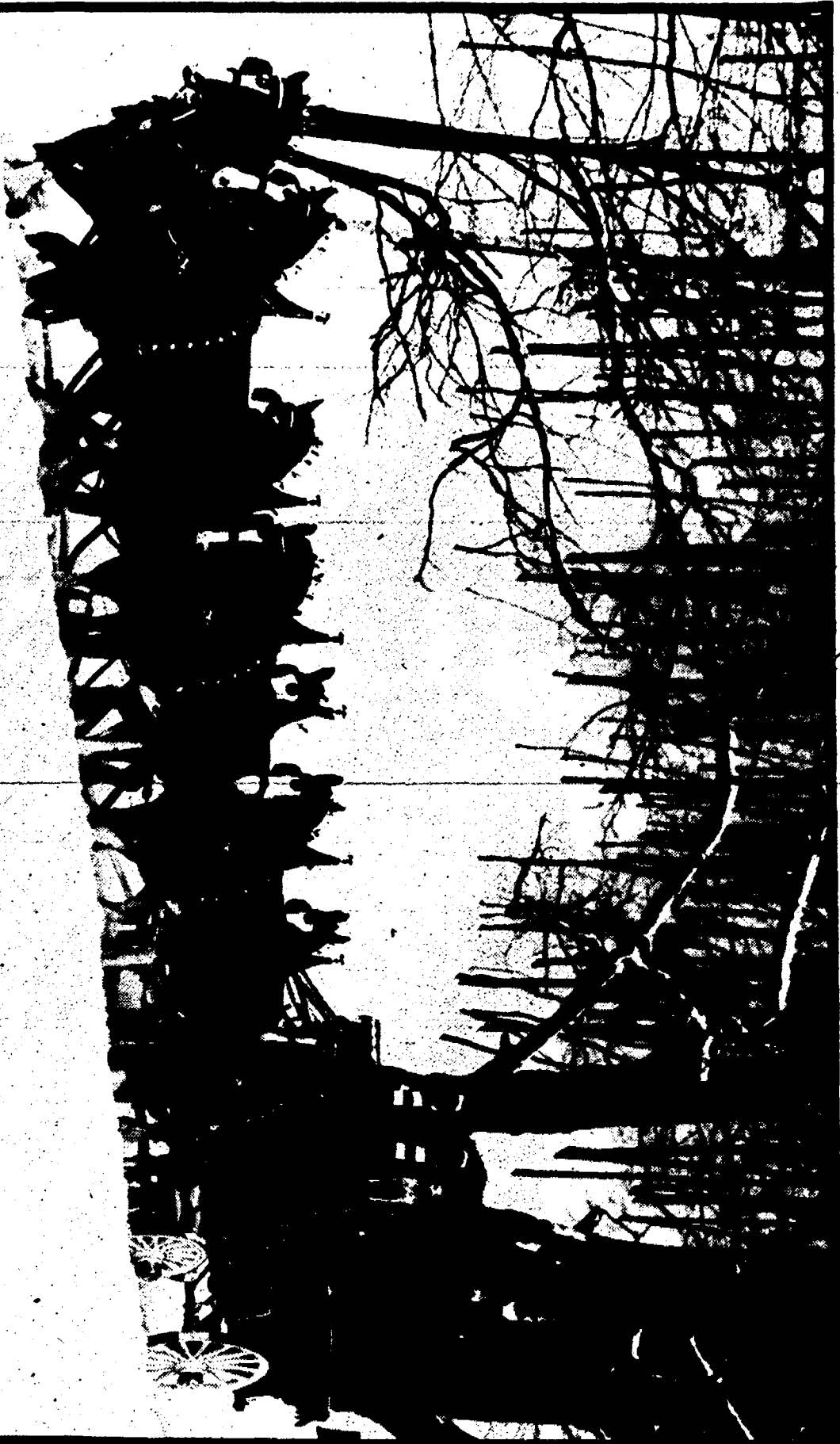
Committee met with Supervisor James Poole Friday to discuss a proposed Canton Flower Festival.

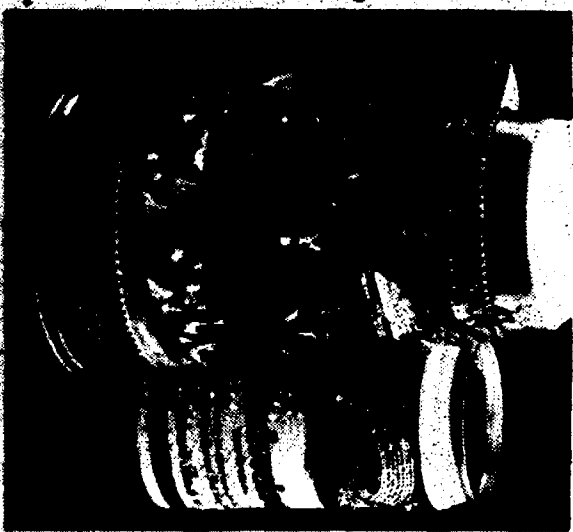

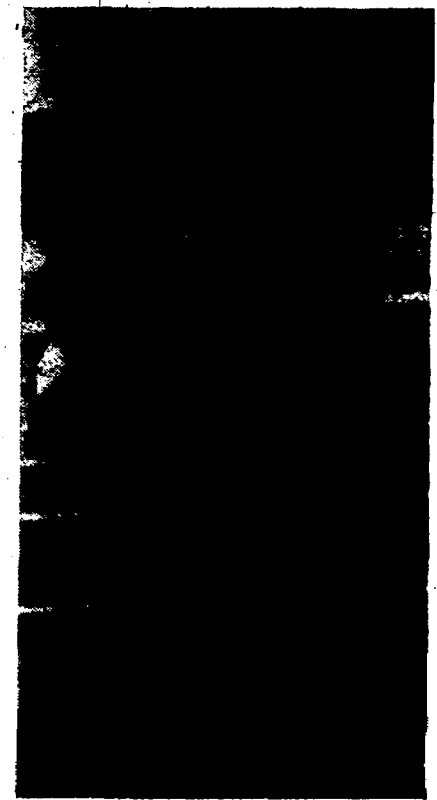

**Berry targets Rock for license revocation**

Plymouth Township Police Chief Carl Berry has taken to the offensive.

At the close of last Tuesday's Township meeting, Berry presented the board of trustees with a request asking that an investigation be initiated to determine whether sufficient evidence exists to revoke the liquor license of the

Plymouthrock Saloon.

Berry asked that an attorney be hired by the township to review the evidence provided by the police in accordance with Ordinance 84 of Plymouth Township.

Berry's support met with unanimous approval from the board.

Ordinance 84 establishes procedures

and standards to review the applications, renewals and revocations of liquor licenses in Plymouth.

Berry intends to focus the investigation on Ordinance 84's Section Two, articles A and B, which deal with objections to license renewal and requests for revocation.

"The question is whether we have an enforceable ordinance," said Berry. "If so, the question then becomes whether or not we have to review liquor licenses."

"At this point, the Rock is the place that we're investigating, but the

problem is not just with the Rock, there are others," said Berry.

Berry, though, firmly maintained that the problem of abuse is not entirely the fault or in the hands of law enforcement.

"Law enforcement is a stop-gap. It doesn't solve the problem," said Berry. "They (drinking establishments) have got to start policing themselves. I'm tired of seeing people dying on the street and the high incidence of alcohol abuse. I know it's a helluva lot to ask, but that's all I want."

**Larson submits resignation**

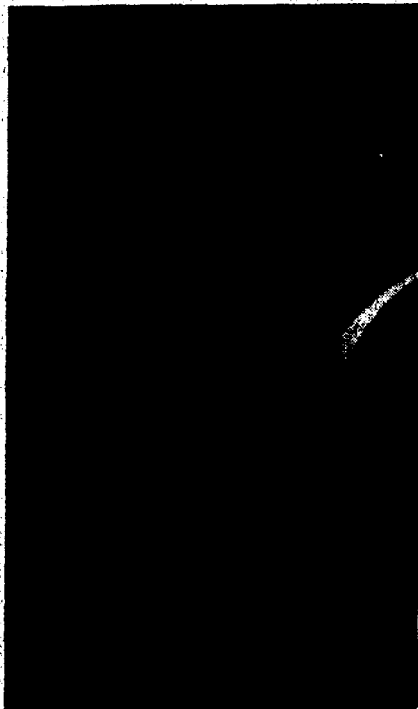
Canton Trustee Stephen Larson officially resigned from the Board of Trustees in a letter to the board dated Dec. 16.

Larson, who had been the senior-most member of the board, moved to Livingston County last week. "I have resigned from the board of trustees because I no longer live in Canton," Larson said.

In his letter of resignation, Larson expressed thanks to the citizens of Canton, employees of the township, and fellow board members he has served with since he became a trustee 10 years ago.

Larson's resignation will be formally considered at the board's regular meeting Tuesday night. The board will have 45 days after accepting the resignation to appoint a replacement trustee. If the board fails to appoint a trustee (through a split vote, for example), a special election would be called.

Larson said he hoped the board would appoint a replacement as soon as possible and avoid the special election.

**Twp. police, trustees agree on contract**

Plymouth Township police officers are signatures away from the first negotiated union contract in the history of their department.

Township police officers in the Police Officers' Association of Michigan (POAM) union and the Plymouth Township Board of Trustees agreed to ratify the contract after final negotiations last Tuesday.

"The document covers a multitude of topics ranging from scheduling to wages," said Plymouth Township Police Chief Carl Berry. "It's really hard to be specific yet. It's not signed, it's only been ratified."

"I'm not going to say that everyone is in love with it, but I feel it's a good, reasonable compromise on both sides," added Berry. "The key is to deliver to the citizens, and I know that

the union recognizes this. The Township gets good service -- we've got good cops."

Currently, Township police work under individual contracts.

"We're happy to have it resolved," said Township Supervisor Maurice Breen. "We both have something we can live with."

# Ordinance would outlaw hunting in Township

Hunters in Plymouth Township may soon be in for some bad news if a proposed anti-hunting ordinance is passed by the Plymouth Township Board of Trustees.

The proposed ordinance is the product of a Hunting Committee which included Township Trustee Smith Horton, a representative of the Department of Natural Resources, a Michigan State police officer and a Wayne County Sheriff's deputy, said Township Clerk Esther Hulsing.

Hulsing noted that the ordinance would prohibit hunting or the discharge of a firearm. Bow hunting would still be legal.

The Western Wayne Conservation Club, which is located as a target range occupying 40 acres along Napier Road, would be exempt from the ordinance, said Hulsing.

Hulsing said that she thought the ordinance would pass. Once passed, a township attorney would create a legal draft of the ordinance for the record.

# Geer School rehab nears \$20,000 mark

Funds for the Geer School restoration project are approaching the \$20,000 mark according to information recently published in the Plymouth Canton Community Schools.

Money has been raised through a variety of methods including the sale of pencils, school tours, bake sales, yard sales and Geer School plaques.

Funds for the project will be used to help restore the school to its condition as it looked in the 1880s when Geer was a thriving schoolhouse.

The Geer School Restoration

Committee is sponsoring the fundraising drive, but the district is also pitching in to fix the school's roof.

Tax deductible donations should be made to the Educational Excellence Foundation and be specified as being for Geer School restoration.

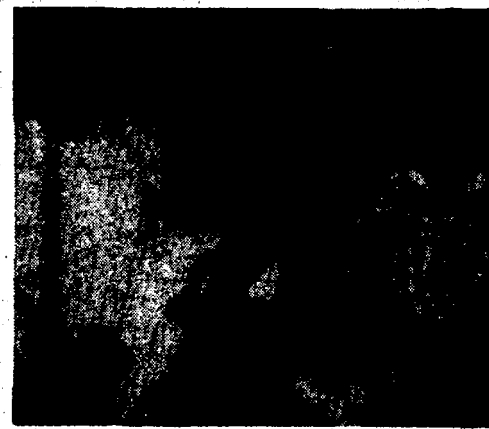

# Man rescued from rollover

An Inkster man is hospitalized in stable condition after being trapped under a pickup truck in a ditch with his head under water for five minutes Tuesday, Canton police said.

The 31-year-old man was a passenger in a vehicle that was broadsided by a car on Denton Road at Geddes Road at about 4:45 p.m., according to Police Information Officer David Boljesic.

"When officers got to the scene, they saw a pickup truck on its side in the ditch," Boljesic said. "Apparently, one of the passengers was submerged in water for about five minutes. The rescue crew managed to free him."

The driver of the truck, a 31-year-old Canton man, fled the scene after the accident, according to witnesses. Canton police arrested the man and are seeking a warrant for his arraignment on charges of leaving the scene of a personal injury accident and driving under the influence of alcohol, Boljesic said.

"Drinking is believed to be a factor" in the accident, Boljesic said.

The pickup truck was traveling north on Denton Road when it collided with a car going west on Geddes Road, Boljesic said. The pickup truck failed to stop at a stop sign on Denton Road, according to witnesses.

The car was driven by an 18-year-old Plymouth woman, Boljesic said.

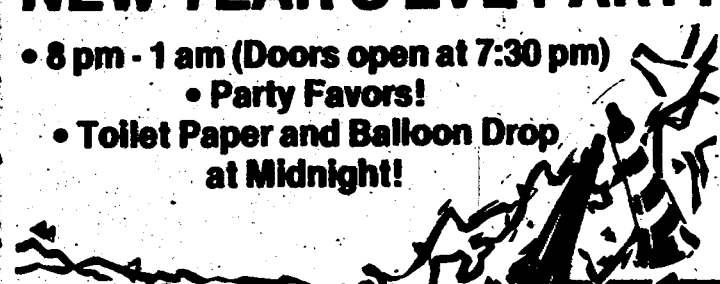

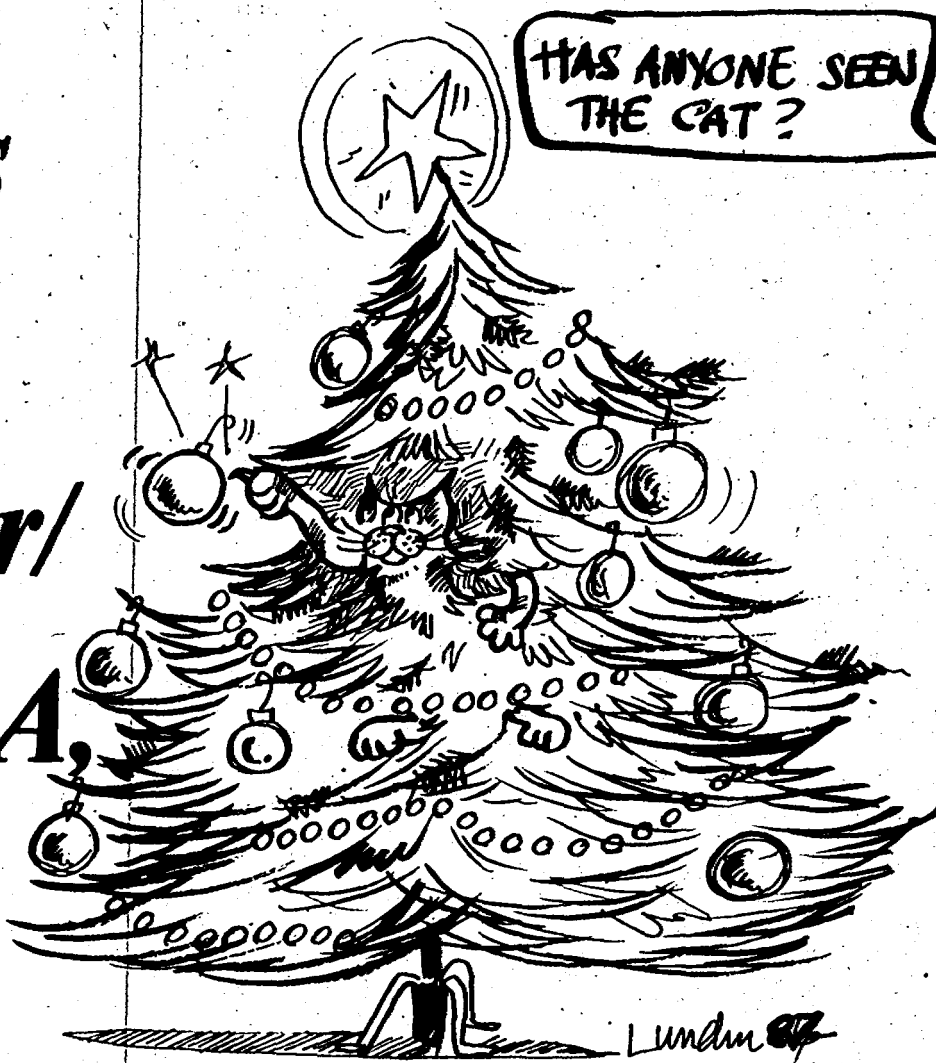

## Tanger move a matter of timing

Converting Tanger Elementary School from a K-5 facility to one for special programs and services when the Plymouth Canton Community Schools district faces still further housing difficulties may not be the right step.

It is an interesting proposal, though; one the board of education feels may actually help the district meet future housing circumstances by centralizing the housing of special student programs.

The problem is one partly of timing.

The new Hoben Elementary School will be opening to students in the fall of 1988, taking some of the burden off district housing planners, but there is already a lot of talk about further growth and development, especially in the northwest corner of the district.

Growth. That's the key word here. The expansion of the student population could very well force the district to consider building yet another elementary school by the year 1992.

By then Tanger may have to be reconverted back into a K-5 facility. The cost and other ill effects (on the student body) will have to be weighed. And with the district's other elementary schools already on the edge of overflowing, one has to wonder how wise the move will be in the long run.

Tanger just might become another Starkweather Center, a thriving community within the district community. That's good. The district has done wonders at Starkweather ever since it closed its doors to regular classes.

On the other hand, Tanger might never meet its potential, or get a chance to meet its potential as a special center for student programs, and once again be delegated to its original use. In the meantime, all of the shifting about of students will only increase the confusing student housing picture.

The bottom line, though, is whether it is wise to disrupt the students at Tanger by shifting them to Farrand Elementary School just so the district can centralize some of the programs it offers.

Would it not be better to consider the conversion of Tanger further on down the line when the growth of the student (and community) population can be more clearly established?

For all intents and purposes the conversion of Tanger is a good idea, that is if the school can grow into its new role as a center for special, alternative programs.

It's just that the timing seems all wrong right now.

### Magic bus line upsets Canton man

It's a matter of inches. Well, maybe, it's feet.

And satisfaction.

There's little doubt Phil Haremski of Canton is both frustrated and angry at the Plymouth Canton Community Schools.

Haremski is fighting to get his little daughter bused to Figel Elementary School on Joy Road. The only problem -- the Haremski home is just outside the magical eligibility "line," or less than one mile walking distance to Figel.

For the past 18 weeks Haremski has been trying to convince the district that the measurement is not only wrong, but unfair. He also claims there may be plenty of inconsistent (read: wrong)

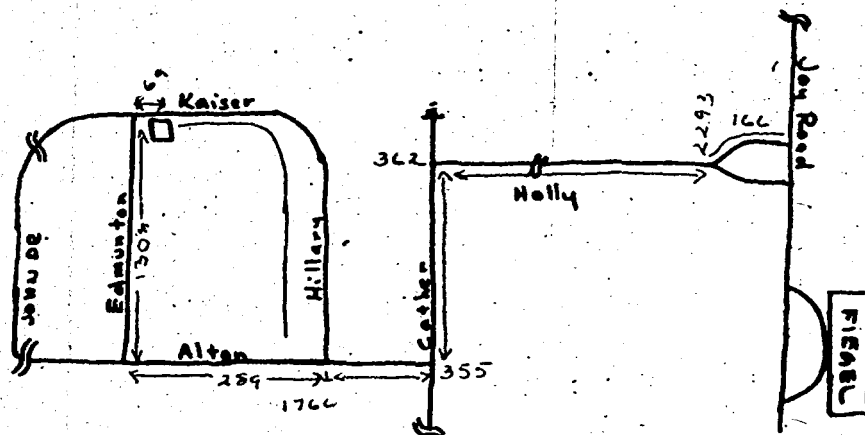
measurements throughout the district.

The district policy calls for kindergarten students to be bused only when they are at least one mile from the school. Haremski has spent hours using a measuring wheel, testing the distance. Despite claims to the contrary, he is certain it is longer than one mile.

But district officials disagree.

Dale Goby, director of transportation in the district, says the walk has been measured twice and it falls in under a mile.

"He sure is into precision," Goby said, referring to Haremski. "We measured that whole area twice and it's under a mile."



Goby said the current busing policy has been in effect since 1973. "There has been no effort to change it," he said.

To change it, Goby added, would mean remeasuring the entire district. In the end, he said, only a few houses would be affected.

"I've battled with the district for 18 weeks. Somebody at the schools should take the local procedure and define it more clearly," Haremski said. "They need to be consistent."

"It's a matter of inches for me," he continued. "They're not providing what I'm paying for. I don't intend to drop it."

Amid all of the technical confusion

and numbers -- Haremski has detailed records of his own attempts to measure the walk -- there is real confusion.

Nobody seems to know, or what to admit exactly where each measurement is supposed to begin. It could be the door handle of the school, the front walk, the center of the driveway, or one of the entrances.

Haremski just wants some satisfaction. If not for him, for others, many of whom may also face being "on the line."

And that's what it comes down to. An eligibility line, which some say should be eliminated altogether. Abstract, technical, confusing.

To bus or not.

And to be very human about it.

I've always tried to miss chuckholes, a winter-time nuisance, but from now on will avoid them with fear. A large one on Haggerty Road in Plymouth Township did in my car last week.

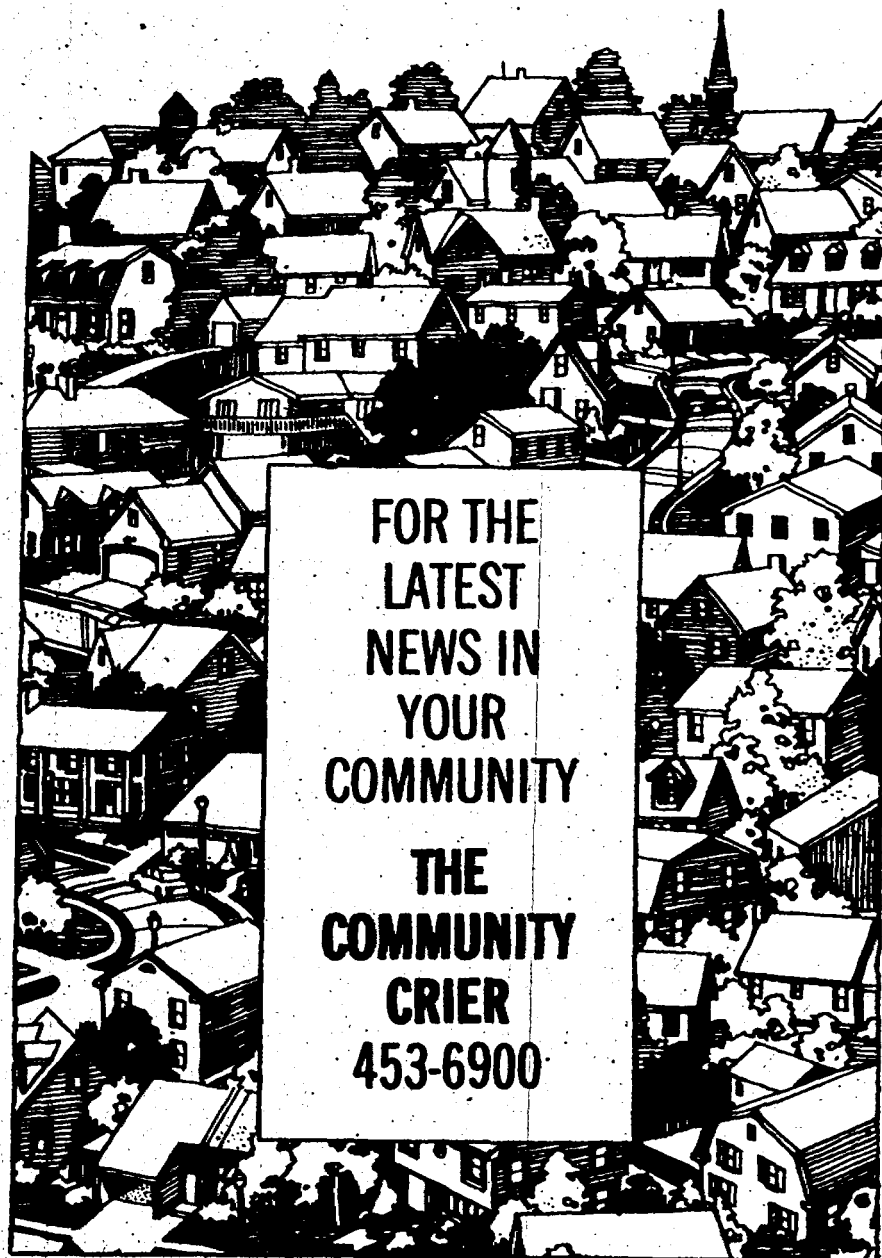

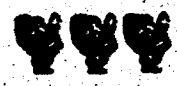

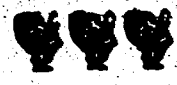
There's no doubt in my mind, of course there's a Santa Claus -- how else would all these miracles come true?

## Chief warns against fraud

Responding to a series of complaints received by fire departments throughout lower Michigan, the state Fire Inspector's Society has issued a warning regarding the prevalence of dangerous and fraudulent servicing of fire extinguishers and restaurant fire-suppression systems by companies claiming to be trained in this capacity.

Al Matthews, Plymouth Fire Chief, recently attended a seminar of the Michigan State Certified Fire Fighters and addressed the concerns of the Fire Inspector's Society. He warned that there are a number of companies who employ a variety of methods and use illegal authorization to gain access into restaurants and businesses to perform the "service."

Matthews noted that the fraudulent companies may represent themselves as agents of the local fire department or

as a fire marshal.

He also stated that they may pretend to be a service representative from a legitimate company. An immediate cash payment is always demanded.

Intimidation is a common tactic. Companies with only one employe in the store are a likely target and those who refuse the service are often threatened with being closed down by the fire marshal.

In addition, Matthews stated that these companies operated during the evening hours and on weekends when store owners were likely to be gone. Proper servicing is not being performed by these companies, he said.

Those businesses with any doubts regarding their portable fire extinguisher or hood system service company are encouraged to contact their local fire marshal.

## Police arrest woman

A Canton couple returned to their Lotz Road home shortly after 9 p.m. on Dec. 14 to find a visitor's car parked in their driveway, according to Canton police.

The couple parked in a neighbor's driveway and walked to their house, at which time the driver of the car in the driveway began honking until two men ran from the house carrying belongings of the couple.

Canton police traced the car's license plate to Linda Zemke, 19, of Dearborn

Heights, who was then arrested in connection with the visit. She was arraigned on Dec. 15 in 35th District Court in front of Judge James Garber on charges of breaking and entering. Canton police said.

Police are also seeking warrants for two Detroit men in connection with the breaking and entering, police said.

Zemke was held on \$25,000 bond, or 10 per cent, and faces trial on Dec. 28 in 35th District Court.

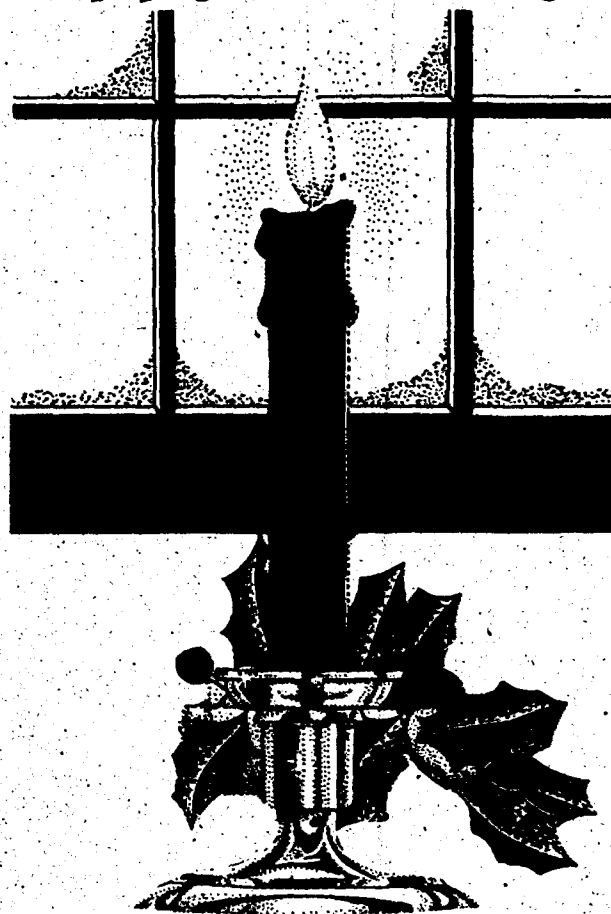
Prizes were awarded to residents and resident managers at the district, area and regional level. The LaRues won at the area level and were awarded \$200 for Best Resident Participation.

those people. They always brought good things.

Working through a number of interviews and medical inspections, Quach's immediate family was eventually sponsored by the Rosedale Garden Presbyterian Church in Livonia.

Minh Quach was on his way to a new life.

"When we heard our serial number called, we thought we were in heaven, but we were called before my uncle and grandfather's family, so we were also a little sad," recalls Quach. "They gave us three days to get ready, but we didn't have much to pack.

"From there we went to Singapore where we went through more paperwork, then it was on to Hong Kong," says Quach. "After that, there were no more interpreters and we all split up for our different countries."

Quach remembers following his father and doing as he was told. It was not until recently that his father confided in him how scared he was traveling in foreign lands with his small family.

"When we got off of the plane in Detroit, there was a big sign that said 'Welcome to America' written in Vietnamese," says Quach. "Dad was

so relieved."

The Quaches stayed with the minister until an apartment was found for them in Canton.

"We can never forget our sponsors who were so nice to us. They took us shopping and helped us with the language," recalls Quach. "We owe them, they were like family."

Quach entered Gallimore school in the fifth grade, beginning an academic career marked by success. Indeed, there was some pain involved and he vividly remembers spending many of his early months alone on the playground.

With patience and determination, he survived and succeeded.

Today Quach is an active member of the Salem High School community. A natural dancer, he will choreograph this year's high school production of the "King and I" and plans to participate as a returning letterman to the boys track team.

Scholastically, Quach is an achiever, fluent in four languages, he is currently studying Spanish and was recently honored as an Elks' Student of the Month.

After high school, Quach hopes to attend Michigan State University and then, perhaps join his parents at their new home in California.

Somehow, it seems almost certain that he will go far beyond success.

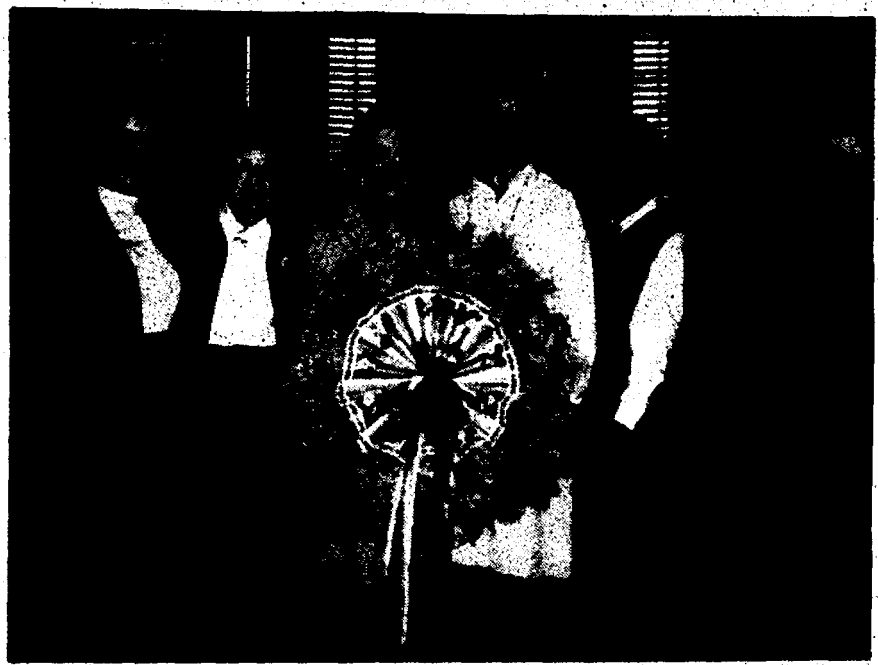

Tom Flores took first at 105 pounds, while Josh Barrie captured his match at 126 pounds.

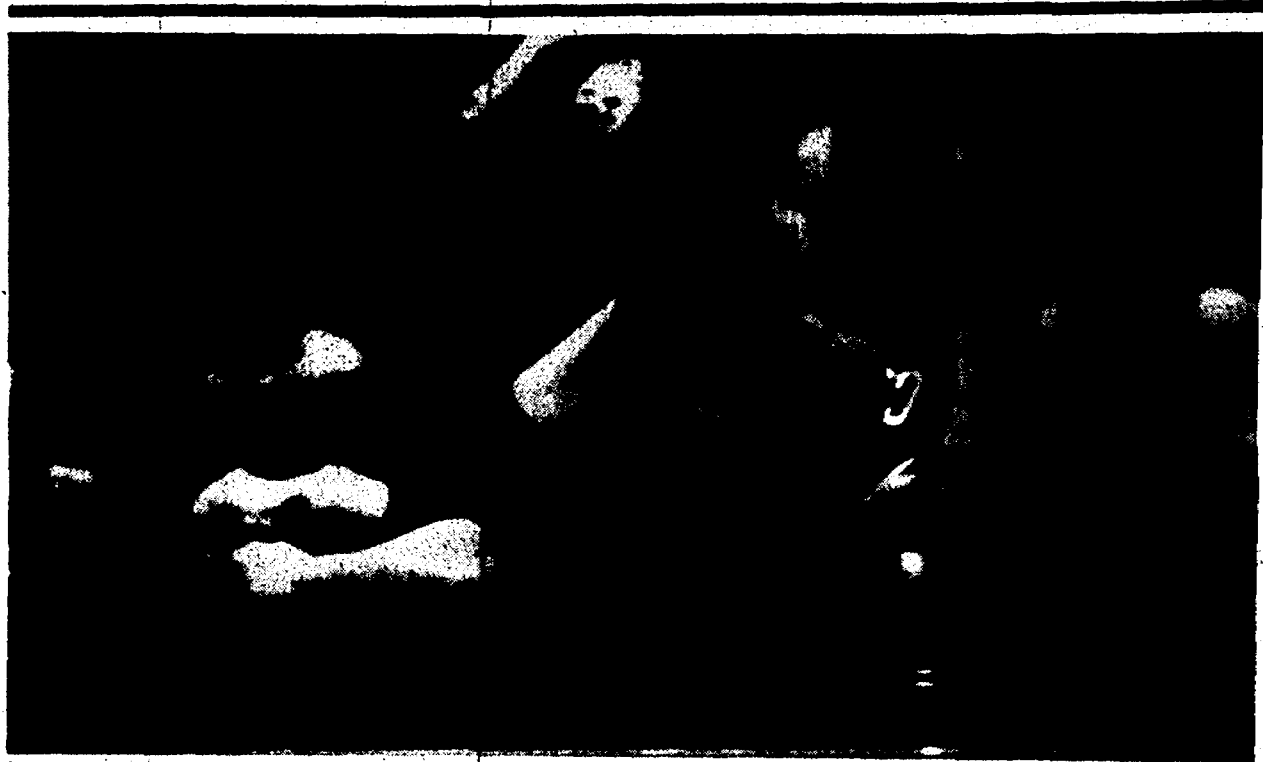
Tim Nadini finished first at 132 pounds and Liam Rentz captured the 138-pound weight class.

Estey is no slouch in the classroom either, as she maintains a 3.8 grade point average, and she is also a member of the National Honor Society.

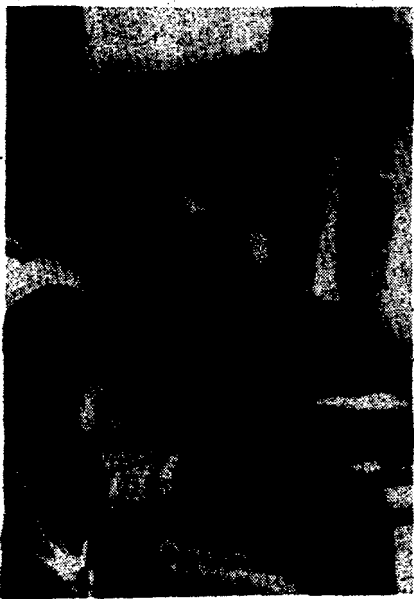
Salem will lose Head at the end of the school year, but Estey will still have on year remaining.

"Dena is a great overall athlete. She can do it all," Salem girls head basketball coach Fred Thomann said.

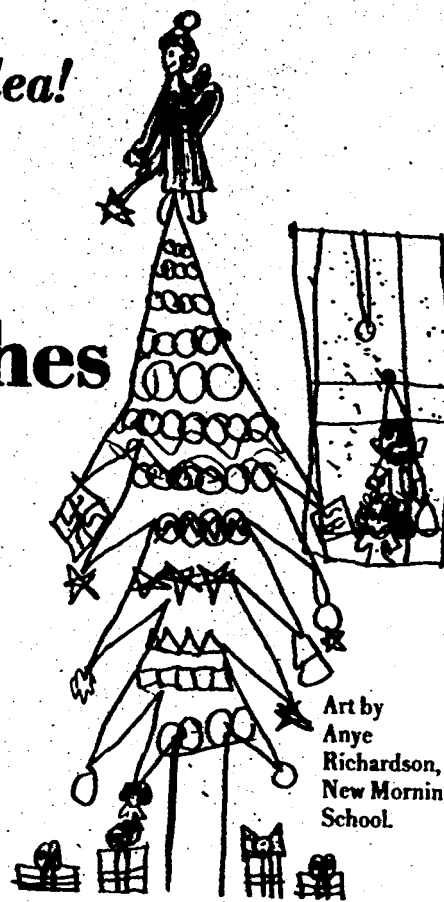
Head is also an excellent student. She has earned a 3.4 grade point average, and has decided that she will pursue a career in medicine.

# Jr. hoop program produces winners

With 23 years in the youth basketball business, it might be safe to assume the Plymouth-Canton Junior Basketball Association (PCJBA) has built a good reputation.

The league consists of approximately 750 to 800 players from the third grade through the 12th grade as well as 75-80 volunteer coaches. On top of that the league employs another 75-80 students from the ninth grade and up for the refereeing responsibilities.

"It's been great for this community," said Bob Blohm whose own involvement in the game of basketball in Plymouth covers more than 12 years.

Blohm said: "It provides an opportunity to develop skill and to have fun at the same time."

With that in mind it's probably safe to say that the community is lucky to have such a fine program at our fingertips as are the varsity teams at the two high schools.

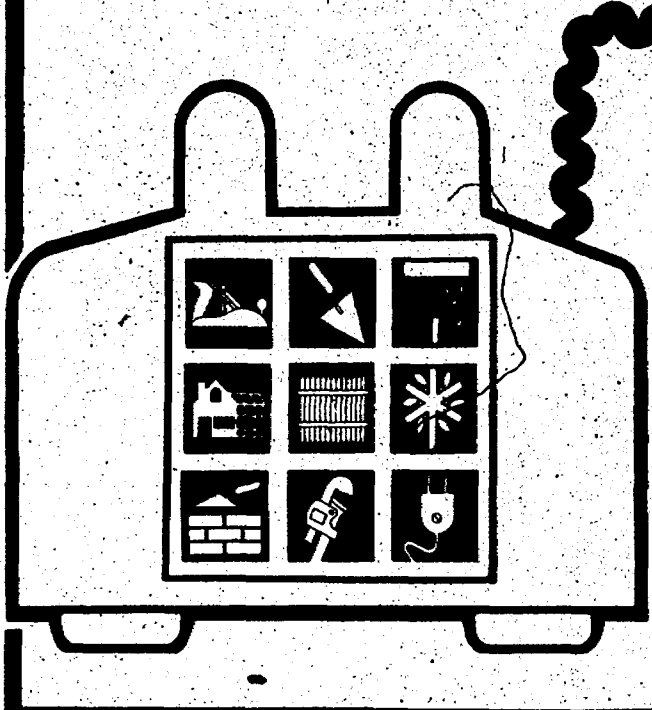

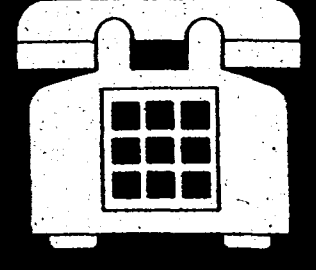

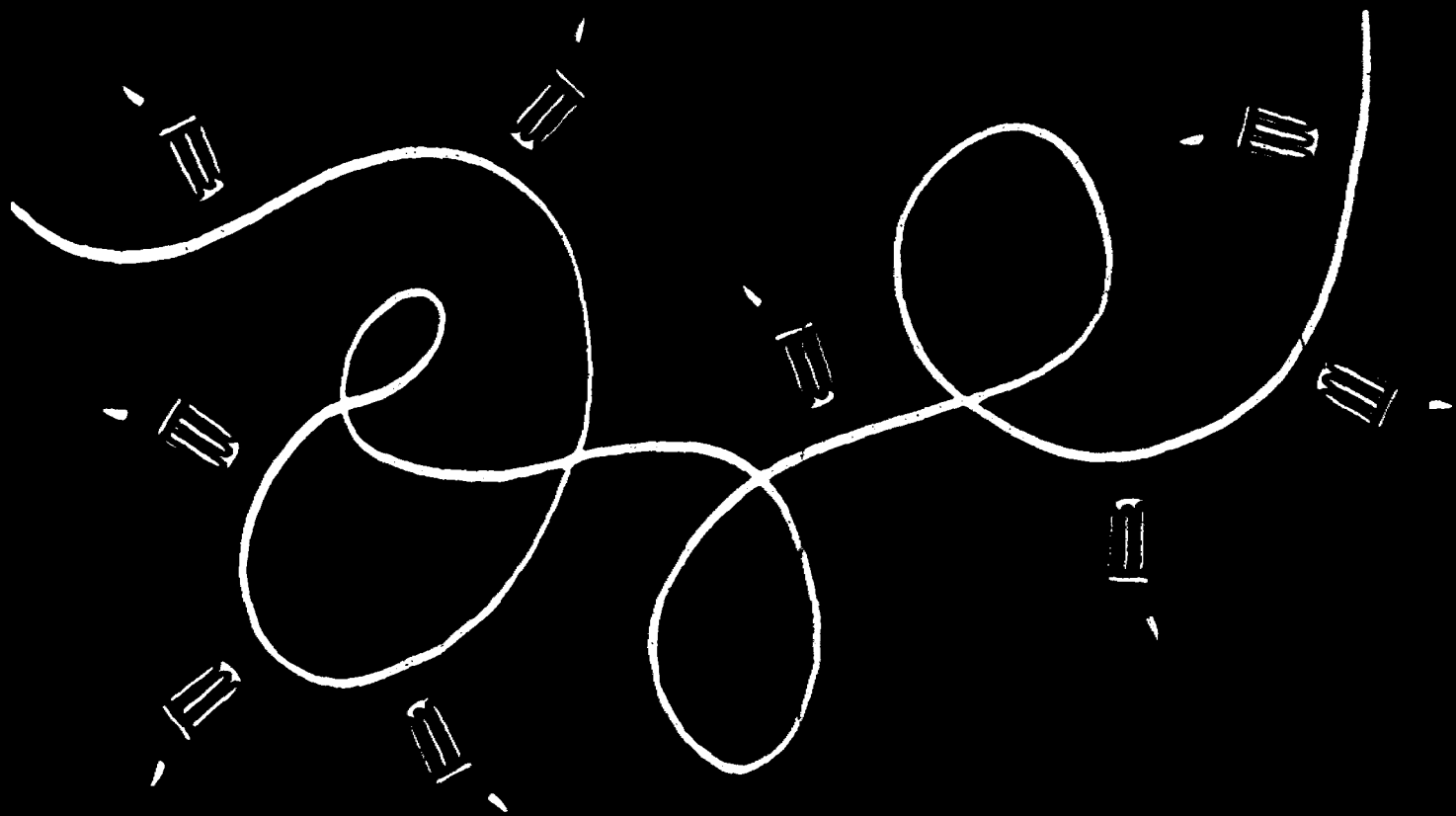
